

Eligibility Criteria for Civil Works under Project Strengthening of Facilities at BUITEMS

- a. Valid Registration Certificate of license d by the Pakistan Engineering Council (PEC) in the
- b. **category C- 3 and above** with specialization code CE - 01 , CE - 09 , CE - 10 and EE - 11 their license should be valid for the December 202 4 year along with CV of Engineer, PEC registration.
- c. Registration Certificates from Income Tax (FBR), Sales Tax (if required) and Balochsitan Revenue Board along with Tax Returns of last three years.
- d. Documentary Evidence / Work orders of minimum last 05 years of similar nature or work category completed with last 05 years completion certificates.
- e. Bank Statement of last three year.
- f. Financial Status Assessment. The applicant is required to submit audit financial statement by a chartered accountant firm f or last three years.
- g. Complete Company / firm profile with detail s of project of similar natures, list of employees and equipment. Complete details of machinery on Company's letter head and duly signed.
- h. Affidavit of the Contractors / firm that they are not involved in any litigation, departmental rift or abandoned or unnecessary delayed completion of any work in the Government and as well as in private organization.
- i. A certificate / affidavit that the firm has not been black listed or debarred by any Government / Autonomous / Private Organization.
- j. Physical presentation of the professional staff and other original documents as deemed by the prequalification / procurement committee will be responsibility of the applicant as and when requested. In the case of failure the firm / company will not be considered.
